Attendance at monthly meetings continues to increase with several new members joining throughout the year.

Members continue to support the walks in Cardiff and Barry.

Other Events

The AGM was held in June and was attended by committee members plus 30 (estimated) members. This meeting also celebrated the charity's 20th anniversary.

In October the charity organised a fund-raising fashion show which was attended by over 50 people. This event raised £1112.90.

The committee meet during the year on 3 occasions to discuss the ongoing issues affecting the charity and its activities – 16^{th} February, 18^{th} May and 31^{st} August.

2 newsletters were issued in 2023 - in May and November.

Funding

Total income for the year was £1607.46 from collections at meetings (£204.56), £290 from a collection at the 20th Anniversary & AGM and £1112.90 raised at the October fashion show. Expenditure was £1678.43 which included the production of the newsletter (£478) and maintenance of the website (£247.16). £574.63 was spent on the 20th Anniversary celebration which was attended by over 50 members and guests.
